Returned Goods Policy

MWI Animal Health's returns policy closely follows the EU Guidelines on Good Distribution Practice (2013/C 343/01).

All returned goods must be in perfect original condition; not marked in anyway, should not show any evidence of being tampered with, including the opening of the outer packaging of the product and carry a product license number where appropriate. Date and Batch managed products will be checked against the original pick order, and only if they match will a credit be issued. A product whose inner packaging has been opened cannot be accepted for return for credit. Goods must be accompanied by a 'Returns Note'. If returning multiple items, they must be packaged in quantities of 20kgs or less.
